The parents, guardians, or undersigned persons enrolling said child (ren) hereby give their consent that the child (ren) enrolled will be subject to all rules and regulations of The Pentecostal Christian Academy as promulgated by the Board of Administrators.

This contract is essential for The Pentecostal Christian Academy to secure and maintain the necessary faculty and physical facilities for the education of the child (ren), which the parents, guardians, or undersigned persons, wish to enroll in its school. **Tuition payment is due the 8<sup>th</sup> of each month. account has a balance at the end of the month, the student(s) will not be allowed to attend classes the following school day unless the outstanding balance is paid in full.** I understand that I am responsible for the full amount of this contract unless released for the remainder of the balance by the Board of Administrators in writing.

While I expect school authorities to exercise reasonable precaution to avoid injury, I understand that neither the Board of Administrators of The Pentecostal Christian Academy nor any of its agents or employees is responsible for any iuries or damages sustained by my child (ren) because of or in any way connected with hiser/their picipation in school activities.

For new students, this agreement is conditioned upon the Pentecostal Christian Academy's acceptance hereof and upon said child (ren) meeting all enrollment requirements.

The undersigned acknowledges and agrees that The Pentecostal Christian Academy retains the right at any time during the period of this contract to terminate this contract and dismiss the student(s) from the Pentecostal Christian Academy if, in the discretion of the Board of Administrators, such action is warranted.
